CERTIFICATE OF WATER RIGHT

WELCH, COLLINS, DICKENSON AND WALLER

CANCELED

confirms the right to use the waters of the ROGUE RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION OF 10.7 ACRES.

This right was perfected under Permit 12635. The date of priority is MAY 7, 1937. This right is limited to 0.134 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$) for Welch, Collins and Dickenson and
LOT 1 (SE $\frac{1}{4}$ NW $\frac{1}{4}$) for Waller, SECTION 15, T 34 S, R 1 W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 1 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)	DOMESTIC AND STOCK
LOT 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)	0.90 ACRE (Welch)
LOT 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)	0.75 ACRE (Collins)
LOT 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)	2.00 ACRES (Dickenson)
LOT 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)	1.15 ACRES (Waller)
LOT 1 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)	5.90 ACRES (Waller)

This certificate describes that portion of the water right confirmed by Certificate 67206, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered OCTOBER 15, 1993, approving Transfer Application 6765.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
