CANCELED

confirms the right to use the waters of PINE CREEK, a tributary of the POWDER RIVER, for IRRIGATION OF 640.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The dates of priority are 1864 FOR 120 ACRES; 1872 FOR 140 ACRES; 1892 FOR 40 ACRES; 1900 FOR 20 ACRES; 1904 FOR 80 ACRES; AND 1909 80 ACRES AND APRIL 1863 FOR 160 ACRES.

The use is limited to 1/40th OF ONE CUBIC FOOT PER SECOND PER ACRE; AND SHALL BE SUBJECT TO ALL OTHER CONDITIONS AND LIMITATIONS CONTAINED IN SAID DECREE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

L.B. AND O.P ISON DITCH FOR 480 ACRES WITH PRIORITIES OF 1864, 1872, 1892, 1900, AND 1909;
