CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SK FARMS

confirms the right to use the waters of the COLUMBIA RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION OF 7582.6 ACRES.

This right was perfected under Permit 37150. The date of priority is JULY 25, 1973. This right is limited to 140.1 CUBIC FOOT PER SECOND, provided the total quantity diverted under this portion of the right perfected under 37150 does not exceed 140.1 cfs, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 7 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), SECTION 2, T 4 N, R 25 E, WM; 150 FEET SOUTH AND 2990 FEET WEST FROM THE NE CORNER, SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
