CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

COOLEY'S GARDENS, INC.
P.O. BOX 126
SILVERTON, OREGON 97381

confirms the right to use the waters of A WELL in the PUDDING RIVER BASIN for IRRIGATION OF 22.1 ACRES.

This right was perfected under Permit G-10813. The date of priority is OCTOBER 29, 1987. This right is limited to 0.28 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within DAVIS DLC 46, SECTION 33, T 6 S, R 1 W, WM; 2195 FEET NORTH AND 410 FEET EAST FROM THE SW CORNER, DAVIS DLC 59.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

both as projected within COX DLC 58
SECTION 4
TOWNSHIP 7 SOUTH, RANGE 1 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 61119, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered DECEMBER 10, 1993, approving Transfer Application 6911.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
