CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARTIN HANSEN
CAMP SHERMAN, OREGON 97730

confirms the right to use the waters of LAKE CREEK, a tributary of the METOLIUS RIVER, for IRRIGATION OF 39.41 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for DESCHUTES County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 9, at Page 362. The date of priority is 1888.

The use is limited to 3 ACRE-FEET PER ACRE, MEASURED AT THE POINT OF DIVERSION FROM THE STREAM, WHICH MAY BE DIVERTED AT A RATE OF NOT TO EXCEED 1/60TH CUBIC FOOT PER SECOND PER ACRE DURING THE IRRIGATION SEASON FROM MAY 1 TO SEPTEMBER 15, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 16, T 13 S, R 9 E, WM; 2320 FEET SOUTH AND 1120 FEET WEST FROM NE CORNER, SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

SECTION 16

TOWNSHIP 13 SOUTH, RANGE 9 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 49695, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Hearings Referee entered January 22, 1991, at Special Order Volume 45, Page 55, and August 12, 1993, at Special Order Volume 47, Page 283.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
