CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION 72.1 ACRES.

This right was perfected under Permit 35846. The date of priority is DECEMBER 23, 1970. This right is limited to 0.90 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within the HODGES DLC 48, SECTION 14, T 10 S, R 4 W, W.M.; 3380 FEET NORTH AND 3570 FEET EAST FROM THE SW CORNER OF SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$	3.7 ACRES
SE $\frac{1}{4}$ NW $\frac{1}{4}$	3.2 ACRES
NE $\frac{1}{4}$ SW $\frac{1}{4}$	31.8 ACRES
NW $\frac{1}{4}$ SW $\frac{1}{4}$	10.7 ACRES
SW $\frac{1}{4}$ SW $\frac{1}{4}$	4.0 ACRES
SE $\frac{1}{4}$ SW $\frac{1}{4}$	3.3 ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$	15.4 ACRES

all as projected within HODGES DLC 48  
SECTION 14  
TOWNSHIP 10 SOUTH, RANGE 4 WEST, W.M.

This certificate is issued to confirm a change in character of use and cancellation of a water right approved by an order of the Water Resources Director entered July 28, 1994, approving Transfer Application 6527, and supersedes Certificates 49095 and 48996, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
