CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MILDRED P. BETHELL P.O. BOX 214 STAYTON, OREGON 97383

confirms the right to use the waters of A SUMP WELL in the NORTH SANTIAM RIVER BASIN for IRRIGATION OF 0.1 ACRE AND SUPPLEMENTAL IRRIGATION OF 0.8 ACRE.

This right was perfected under Permit G-1255. The date of priority is FEBRUARY 19, 1959. This right is limited to 0.01 CUBIC FOOT PER SECOND, if available at the original well; $NW^{\frac{1}{4}}_{\frac{1}{4}} SW^{\frac{1}{4}}_{\frac{1}{4}}$, SECTION 15, T 9 S, R 1 W, WM; 26 CHAINS NORTH AND 25 CHAINS WEST FROM THE S¹/₄ CORNER, SECTION 15, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE¹/₄ SW¹/₄, SECTION 15, T 9 S, R 1 W, WM; 1260 FEET NORTH AND 910 FEET WEST FROM THE S¹/₄ CORNER, SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and $2\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

PRIMARY SUPPLEMENTAL

 $SW_{\frac{1}{4}}^{\frac{1}{4}}$ SE¹/₄ 0.1 ACRE 0.8 ACRE SECTION 15 TOWNSHIP 9 SOUTH, RANGE 1 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 55526, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered Oct - 27, 1994, cancelling a portion of the right and approving Transfer Application 6773.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
