confirms the right to use the waters of WILLOW CREEK AND FLORAS CREEK, tributaries of THE PACIFIC OCEAN, for the purpose of IRRIGATING 69.1 ACRES, BEING 24.8 ACRES FROM WILLOW CREEK AND 44.3 ACRES FROM FLORAS CREEK.

The right has been perfected under Permit 44510. The date of priority is APRIL 12, 1978. The right is limited to not more than 0.72 CUBIC FOOT PER SECOND, BEING 0.31 CFS FROM WILLOW CREEK AND 0.41 CFS FROM FLORAS CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WILLOW CREEK - SE 1/4 NW 1/4, SECTION 15, T 31 S, R 15 W, W.M.; 1720 FEET SOUTH AND 680 FEET WEST FROM THE N 1/4 CORNER OF SECTION 15.

FLORAS CREEK - SE 1/4 SE 1/4, SECTION 4, T 31 S, R 15 W, W.M.; 560 FEET NORTH AND 410 FEET WEST FROM SE CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
