CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

H.K. FISHER
HAINES, OREGON 97833

confirms the right to use the waters of ROCK CREEK, a tributary of the POWDER RIVER, for IRRIGATION OF 280.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is 1879 FOR 120 ACRES AND 1872 FOR 160 ACRES.

The use is limited to 1/40 CUBIC FOOT PER SECOND PER ACRE CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

J.K. FISHER AND A. LONG DITCHES FOR 120 ACRES, AND H.K. FISHER AND A. LONG DITCHES FOR 160 ACRES.

A description of the place of use to which this right is appurtenant is as follows:
