confirms the right to use the waters of SPRING CREEK, LITTLE SPRING CREEK, AND SALMON CREEK, tributaries of POWDER RIVER, for IRRIGATION of 398.64 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is 1866 FOR TRACT 1, 1867 FOR TRACT 2, 1880 FOR TRACT 3, 1898 FOR TRACT 4, 1880 FOR TRACT 5, 1867 FOR TRACT 6, AND 1875 for TRACT 7.

The use is limited to 0.715 cubic foot per second for tract 1, 0.488 cubic foot per second for tract 2, 0.575 cubic foot per second for tract 3, 0.20 cubic foot per second for tract 4, 2.977 cubic feet per second for tract 5, 0.989 cubic foot per second for tract 6 and 4.00 cubic feet per second for tract 7 or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.
