CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R.B. OLIVER
BOX 273, IDLEYLD ROUTE
ROSEBURG, OREGON 97470

confirms the right to use the waters of the NORTH UMPQUA RIVER, a tributary of the UMPQUA RIVER, for IRRIGATION OF 45.7 ACRES.

This right was perfected under Permit 12340. The date of priority is AUGUST 31, 1936. This right is limited to 0.57 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 15, T 26 S, R 4 W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW $\frac{1}{4}$ NE $\frac{1}{4}$	6.5 ACRES
SW $\frac{1}{4}$ NE $\frac{1}{4}$	15.4 ACRES
SE $\frac{1}{4}$ NE $\frac{1}{4}$	22.7 ACRES
NE $\frac{1}{4}$ SE $\frac{1}{4}$	1.1 ACRES

SECTION 15
TOWNSHIP 26 SOUTH, RANGE 4 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 43558, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered Mar. 7, 1995, approving Transfer Application 6830, and correctly describes that portion of the same water right NOT modified by the provisions of an order of the Water Resources Director entered February 6, 1976, approving Transfer 3071.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
