CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the FORT ROCK BASIN for IRRIGATION OF 144.7 ACRES.

This right was perfected under Permit G-10760. The date of priority is FEBRUARY 3, 1987. This right is limited to 1.81 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 SW 1/4, SECTION 14, T 26 S, R 13 E, W.M.; 210 FEET SOUTH AND 1302 FEET EAST FROM THE W 1/4 CORNER OF SECTION 14.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4	29.8 ACRES
SE 1/4 NW 1/4	26.1 ACRES
NE 1/4 SW 1/4	34.8 ACRES
NW 1/4 SW 1/4	37.9 ACRES
SW 1/4 SW 1/4	9.5 ACRES
SE 1/4 SW 1/4	6.6 ACRES


The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The user shall maintain the measuring device and keep a complete record of the amount of water withdrawn.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
