CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES J. AND MABEL VIRGINIA LEIBELT HC 85 BOX 591 MYRTLE POINT, OREGON 97458

confirms the right to use the waters of the NORTH FORK COQUILLE RIVER, a tributary of the COQUILLE RIVER, for IRRIGATION OF 22.4 ACRES AND STOCK.

This right was perfected under Permit 29442. The date of priority is MARCH 10, 1964. This right is limited to 0.285 CUBIC FOOT PER SECOND, BEING 0.28 CFS FOR IRRIGATION AND 0.005 CFS FOR STOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 9 (NE¼ SE¼), LOT 9 (SW¼ SE¼), SECTION 2, T 29 S, R 12 W, WM; 1370 FEET NORTH AND 2670 FEET EAST; 1230 FEET NORTH AND 2550 FEET EAST, BOTH FROM THE SW CORNER, LOT 8 (SE¼ SW¼).

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 8 (SE¼ SW¼) 0.4 ACRE
LOT 9 (NE¼ SE¼) 0.7 ACRE
LOT 9 (NW¼ SE¼) 15.8 ACRES
LOT 9 (SW¼ SE¼) 5.5 ACRES
SECTION 2

TOWNSHIP 29 SOUTH, RANGE 12 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 39385, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered _________, approving Transfer Application 6622.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
