CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL in the ALKALI LAKE BASIN for IRRIGATION OF 408.1 ACRES.

This right was perfected under Permit G-4555. The date of priority is APRIL 2, 1969. This right is limited to 5.1 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 SE 1/4, SECTION 13, T 39 S, R 11 1/2 E, W.M.; 2080 FEET NORTH AND 780 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 13.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
