CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVEN R. COOPER AND MYLISSA M. COOPER HC 85, BOX 46 MYRTLE POINT, OREGON 97458

confirms the right to use the waters of MIDDLE FORK COQUILLE RIVER, a tributary of THE COQUILLE RIVER, for IRRIGATION OF 12.05 ACRES AND DOMESTIC USE FOR TWO FAMILIES INCLUDING IRRIGATION OF UP TO ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN FOR EACH.

This right was perfected under Permit 51179. The date of priority is FEBRUARY 20, 1990. This right is limited to 0.16 CUBIC FOOT PER SECOND, BEING 0.15 CFS FOR IRRIGATION AND 0.01 CFS FOR DOMESTIC or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SW 1/4, SECTION 28, T 29 S, R 11 W, W.M.; 2235 FEET NORTH AND 3090 FEET WEST, 2267 FEET NORTH AND 2698 FEET WEST, BOTH FROM THE SE CORNER OF SECTION 28.

Diversion screening or fish passage facilities shall be maintained and operated to Oregon Department of Fish & Wildlife specifications.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4 8.08 ACRES & DOMESTIC - 2 FAMILIES NW 1/4 SE 1/4 3.90 ACRES SW 1/4 SE 1/4 0.07 ACRE SECTION 28 TOWNSHIP 29 SOUTH, RANGE 11 WEST, W.M.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
