CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of THE NORTH UMPQUA RIVER, a tributary of THE UMPQUA RIVER, for IRRIGATION OF 1.07 ACRES.

This right was perfected under Permit 51027. The date of priority is JUNE 11, 1990. This right is limited to 0.013 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 1 (NE 1/4 NW 1/4), SECTION 19, T 26 S, R 4 W, W.M.; 1535 FEET NORTH AND 1725 FEET EAST; 1495 FEET NORTH AND 1685 FEET EAST, BOTH FROM THE WEST 1/4 CORNER OF SECTION 19.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 1 (NE 1/4 NW 1/4) 0.41 ACRE  
LOT 2 (SE 1/4 NW 1/4) 0.66 ACRE  
SECTION 19  
TOWNSHIP 26 SOUTH, RANGE 4 WEST, W.M.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
