CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of THOMAS CREEK AND TRIBUTARIES, a tributary of GOOSE LAKE, for IRRIGATING 90.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for LAKE County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at Page 233. The date of priority is 1880.

The use is limited to THREE-FOURTHS ACRE-FOOT PER ACRE DURING ANY 30 DAY PERIOD PRIOR TO JUNE 1ST, AND ONE-HALF ACRE-FOOT PER ACRE DURING ANY 30 DAY PERIOD AFTER JUNE 1ST, OF EACH YEAR; AND TWO AND ONE-HALF ACRE-FEET PER ACRE DURING ANY IRRIGATION SEASON: TO BE DIVERTED UNDER A HEAD OF NOT TO EXCEED ONE-FORTIETH OF A SECOND FOOT PER ACRE, or its equivalent in case of rotation, measured at the point of diversion from the source. IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION.

The point of diversion is located as follows:

LOT 1 (NW 1/4 NW 1/4) SECTION 30, T 38 S, R 20 E, W.M.; 4761.82 FEET NORTH AND 21.77 FEET EAST FROM THE SE CORNER OF SECTION 25, T 38 S, R 19 E, W.M.

A description of the place of use to which this right is appurtenant is as follows:

This right is subject to all other conditions and limitations contained in said decree.

When in the judgement of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered OCTOBER 18, 1989, and supersedes Certificate 5232, State Record of Water Right Certificates.
