## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD D. AND VIOLET L. KENWARD 4470 RIVERSIDE DRIVE HOOD RIVER OR 97031

confirms the right to use the waters of HOOD RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 1.5 ACRES.

This right was perfected under Permit 51104. The date of priority is MARCH 15, 1990. This right is limited to NOT MORE THAN 0.02 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SE 1/4 SECTION 16, T 2 N, R 10  $\pm$ , W.M.; 685 FEET NORTH AND 1425 FEET WEST FROM THE SE CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 1.4 ACRES SE 1/4 SE 1/4 0.1 ACRE SECTION 16 TOWNSHIP 2 NORTH RANGE 10 EAST, W.M.

Diversion screening or fish passage facilities shall be maintained and operated to Oregon Department of Fish & Wildlife specifications.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.
