CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD CARTWRIGHT AND INEZ CARTWRIGHT

confirms the right to use the waters of SISLEY CREEK, a tributary of BURNT RIVER, for IRRIGATION OF 18.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 14.9 ACRES.

This right was perfected under Permit 50249. The date of priority is OCTOBER 21, 1987. This right is limited to an amount of water that may be beneficially used not to exceed 0.83 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 20, T 12 S, R 44 E, W.M.; 2316 FEET NORTH AND 1815 FEET EAST FROM THE SW CORNER OF SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use to which this right is appurtenant is as follows:

The appropriation allowed herein shall be subject to the proper maintenance of headgate and measuring device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
