CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLAYTON MCCULLOUGH  
8399 ROANOKE DRIVE NE  
BROOKS, OREGON 97305

confirms the right to use the waters of TWO WELLS in the LITTLE PUDDING RIVER BASIN for IRRIGATING 19.3 ACRES.

This right was perfected under Permit G-2445. The date of priority is JUNE 20, 1963. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.24 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The quantity of water appropriated at the new well together with that appropriated from the old well shall not exceed the quantity of water available at the original well under the subject right.

The wells are located as follows:

1 - NW 1/4 NE 1/4, SECTION 14, T 6 S, R 2 W, W.M.; 1320 FEET SOUTH AND 1300 FEET EAST FROM THE SW CORNER OF WEBB DLC 56.

2 - LOT 1 (NE 1/4 NE 1/4) SECTION 14, T 6 S, R 2 W, W.M.; 1193 FEET SOUTH AND 935 FEET WEST FROM THE NE CORNER OF SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When in the judgement of the watermaster it becomes necessary to install measuring devices:

the pump system shall include an access port for measuring the water level;

the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the applicant is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change FOR AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JUNE 8, 1988, and supersedes Certificate 33458, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
