CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN VAN BEEK 26405 MCFARLAND ROAD MONROE, OREGON 97456

confirms the right to use the waters of MUDDY CREEK AND EFFLUENT FROM DAIRY COMPLEX AND ANIMAL WASTE HOLDING RESERVOIR, CONSTRUCTED UNDER PERMIT R-10892, for WASHING IN DAIRY COMPLEX, IRRIGATION OF 12.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 130.7 ACRES.

This right was perfected under Permit 50183. The date of priority is SEPTEMBER 10, 1987. The amount of water to which this right is entitled is limited to an amoun actually beneficially used and shall not exceed 1.845 CUBIC FEET PER SECOND, BEING 0.045 CFS FROM MUDDY CREEK FOR WASHING IN THE DAIRY COMPLEX, AND 1.8 CFS FROM EFFLUENT FROM THE DAIRY COMPLEX AND ANIMAL WASTE HOLDING RESERVOIR FOR IRRIGATION AND SUPPLEMENTAL IRRIGATION or its equivalent in case of rotat on measured at the point of diversion from the source.

The points of diversion are located as follows:

MUDDY CREEK - SE 1/4 NW 1/4, SECTION 17, T 14 5, R 5 W, W.M.; 1700 FEET SOUTH AND 1750 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 17;

COLLECTION TANK - SE 1/4 NE 1/4, SECTION 18 T 14 S, R 5 W, W.M.; 1675 FEET SOUTH AND 700 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 18;

HOLDING POND - SE 1/4 NE 1/4, SECTION 18, T 14 S, R 5 W, W.M.; 1300 FEET SOUTH AND 625 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre, from direct flow and storage from reservoir constructed under Permit R-9974, provided further that although declared hereinto be for supplemental irrigation, the right may, in the interest of proper operation of the manure storage lagoon, be exercised at times when water is available at the primary source provided, that the total quantity diverted from all sources of supply shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
