CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM SMITH PROPERTIES, INC.
15 SW COLORADO AVENUE
BEND, OREGON 97702

confirms the right to use the waters of MITCHELL RANCH RESERVOIR ENLARGEMENT (PAINTED HILLS RESERVOIR) CONSTRUCTED UNDER PERMIT R-9896, a tributary of THE JOHN DAY RIVER, for SUPPLEMENTAL IRRIGATION OF 407.9 ACRES.

This right was perfected under Permit 48540. The date of priority is OCTOBER 17, 1983. This right is limited to 407.9 ACRE-FEET OF STORED WATER ONLY.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 25, T 10 S, R 20 E, W.M.; 1620 FEET NORTH AND 240 FEET WEST FROM THE S 1/4 CORNER OF SECTION 25.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to 4.0 acre-feet for each acre irrigated FROM STORAGE FROM RESERVOIR ENLARGEMENT CONSTRUCTED UNDER PERMIT R-9896.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
