CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of 5 UNNAMED STREAMS AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-11155, tributaries of KENTUCK SLOUGH, for DOMESTIC USE FOR FIVE FAMILIES, INCLUDING IRRIGATION OF LAWN AND GARDEN NOT TO EXCEED ONE-HALF ACRE IN AREA FOR EACH FAMILY.

This right was perfected under Permit 50731. The date of priority is AUGUST 11, 1987. This right is limited to 0.02 CUBIC FOOT PER SECOND, BEING 0.005 CFS FROM DIVERSION POINT 2, 0.01 CFS FROM DIVERSION POINT 3, AND 0.005 CFS FROM DIVERSION 4 AND 2.64 ACRE-FEET STORED WATER FROM AN UNNAMED RESERVOIR or the equivalent in case of rotation, measured at the points of diversion from the sources.

The points of diversions are located as follows:

SW 1/4 SE 1/4 SECTION 1, T 25 S, R 13 W, W.M.; 2 (STREAM 5) - 482 FEET NORTH AND 2332 FEET WEST; 3 (STREAM 4) - 848 FEET NORTH AND 1827 FEET WEST; 4 (STREAM 3) - 373 FEET NORTH AND 2113 FEET WEST; ALL FROM SOUTHEAST CORNER OF SECTION 1.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 1 DOMESTIC  
SE 1/4 SE 1/4 4 DOMESTIC  
SECTION 1  
TOWNSHIP 25 SOUTH, RANGE 13 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
