CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the FORT ROCK BASIN for IRRIGATION OF 114.0 ACRES.

This right was perfected under Permit G-10925. The date of priority is APRIL 4, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.42 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW% SW%, SECTION 5, T 27 S, R 16 E, WM; 1320 FEET NORTH AND 1320 FEET EAST FROM THE SW CORNER, SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon and maintain a weir, meter or other suitable measuring device and continue to keep a complete record of the amount of ground water withdrawn.

The right shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights as well as prior ground water rights of others.

The use granted herein may be made only at time when sufficient water is available to satisfy all prior rights.

The quantity of water diverted at this point of appropriation, together with the quantity of water diverted at other points of appropriation for right developed under this permit, shall not exceed the quantity of water available at the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by Certificate 68444, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director enteredAUG 30 1995, approving Transfer Application 7300
