## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J-SPEAR RANCH CO. P.O. BOX 257 KLAMATH FALLS, OR 97601

confirms the right to use the waters of DRY PRAIRIE CREEK AND SAGEHORN RESERVOIR, constructed under PERMIT-11220, a tributary of LOST RIVER, for IRRIGATION OF 108.2 ACRES AND LIVESTOCK.

This right was perfected under Permit 50966. The date of priority is SEPTEMBER 19, 1988. This right is limited to not more than 1.35 CUBIC FEET PER SECOND, BEING 1.34 CFS FOR IRRIGATION AND 0.01 CFS FOR LIVESTOCK or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 22; SW 1/4 NE 1/4, SECTION 27; NW 1/4 NE 1/4, SECTION 34, T 37 S, R 31 E, W.M.; RESERVOIR - 233 FEET NORTH AND 886 FEET WEST FROM THE SE CORNER OF SECTION 22; CREEK - 2496 FEET NORTH AND 2343 FEET WEST FROM THE SE CORNER OF SECTION 27; AND 823 FEET SOUTH AND 1399 FEET WEST FROM THE NE CORNER OF SECTION 34.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

Water may not be appropriated from direct flow after June 1 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
