CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HAROLD AKES ROUTE 4, BOX 121 MILTON-FREEWATER, OREGON 97862

confirms the right to use the waters of FOUR WELLS in the WALLA WALLA RIVER BASIN for DOMESTIC SUPPLY FOR 70 MOBILE HOMES AND TWO HOUSES INCLUDING IRRIGATION OF UP TO 1/2 ACRE LAWN OR NON-COMMERCIAL GARDEN EACH.

This right was perfected under Permit G-10444. The date of priority is JULY 6, 1984. This right is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.15 CUBIC FOOT PER SECOND, BEING 0.07 CFS FOR DOMESTIC USE AND 0.05 CFS FOR IRRIGATION OF LAWN AND NON-COMMERCIAL GARDEN FROM WELL "E" WITH BACKUP SUPPLIES FROM WELLS "A", "C", AND "D" FOR USE AT MOBILEHOME PARK AND 0.005 CFS EACH FROM WELLS "A" AND "C" FOR DOMESTIC USE AT TWO HOMESITES AND 0.01 CFS EACH FROM WELLS "A" AND "C" FOR IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND GARDEN AT EACH, or its equivalent in case of rotation measured at the point of diversion from the wells.

The wells are located as follows:

NW 1/4 SW 1/4 OF SECTION 25, T 6 N, R 35 E, W.M.; (WELL A) 120 FEET SOUTH AND 820 FEET EAST; (WELL C) 606 FEET SOUTH AND 1230 FEET EAST; (WELL E) 654 FEET SOUTH AND 921 FEET EAST, ALL FROM THE WEST 1/4 CORNER OF SECTION 25

NE 1/4 SW 1/4 OF SECTION 25, T 6 N, R 35 E, W.M.; (WELL D) 600 FEET SOUTH AND 1467 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 25.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 SW 1/4 SECTION 25 TOWNSHIP 6 NORTH, RANGE 35 EAST, W.M.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JANUARY 17, 1990, and supersedes Certificate 63617, State Record of Water Right Certificates.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
