CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

URBACH FARMS, INC. PO BOX 12 DAIRY, OR 97625

confirms the right to use the waters of ONE WELL in the BUCK CREEK BASIN for IRRIGATION OF 1.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 111.9 ACRES.

This right was perfected under Permit G-11312. The date of priority is AUGUST 22, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.42 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

SE 1/4 SW 1/4, SECTION 34, T 38 S, 11 1/2 E, W.M.; 25 FEET NORTH AND 120 FEET WEST FROM THE S 1/4 CORNER OF SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
