CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RONALD R AND JANE I. BAKER

confirms the right to use the waters of TWO WELLS in the UMATILLA RIVER BASIN for IRRIGATION OF 0.2 ACRE.

This right was perfected under Permit G-5044. The date of priority is SEPTEMBER 2, 1970 - FOR WELL 1 AND AUGUST 16, 1971 - FOR WELL 2. This right is limited to 0.002 CUBIC FOOT PER SECOND FROM WELL 1 AND 0.001 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the wells.

The well is located as follows:

SW $\frac{1}{4}$  NE $\frac{1}{4}$ , SECTION 29; SW $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 28, T 4 N, R 28 E, WM;  
1 - 1330 FEET SOUTH AND 1340 FEET WEST; 2 - 1350 FEET SOUTH AND 10 FEET EAST, BOTH FROM THE NE CORNER, SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year; provided further that the wells shall not exceed 190 feet nor appropriate water from an aquifer below the depth of the alluvial gravels.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW $\frac{1}{4}$  NW $\frac{1}{4}$  0.2 ACRE  
SECTION 29  
TOWNSHIP 4 NORTH, RANGE 28 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 48905, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered SEPTEMBER 23, 1994, approving Transfer Application 7102.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

THIS CERTIFICATE IS ISSUED TO CORRECTLY DESCRIBE THE THE PRIORITY DATE AND SUPERSEDES CERTIFICATE 68400.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
