CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SANTIAM WATER CONTROL DISTRICT
11371 DIECKMAN LANE SE
AUMSVILLE, OREGON 97325

confirms the right to use the waters of the NORTH SANTIAM RIVER, a tributary of the SANTIAM RIVER, for the purpose of IRRIGATION OF 1895.7 acres.

This right was perfected under Permit 1401. The date of priority is June 24, 1911. The amount of water to which this right is entitled is limited to an amount of water actually beneficially used and shall not exceed 23.70 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located in Lot 2 (SW 1/4 SE 1/4) Section 11, T.9S, R.1W, W.M., being 1800 feet South and 2830 feet East from W 1/4 corner Section 11.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.


