CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SANTIAM WATER CONTROL DISTRICT
11371 DIECKMAN LANE SOUTHEAST
AUMSVILLE, OREGON 97325

confirms the right to use the waters of the NORTH SANTIAM RIVER, a tributary of the SANTIAM RIVER for IRRIGATION of 1989.60 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for MARION County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 13, at Page 437. The date of priority is May 14, 1909.

The amount of water to which this right is entitled is limited to an amount of water actually beneficially used and shall not exceed 24.9 CUBIC FOOT PER SECOND.

Note: To compensate for losses between the point of diversion to the place of use, an additional amount not exceeding ten percent is allowed.

The point of diversion is located in Lot 2 (SW 1/4 SE 1/4) Section 11, T.9S, R.1W, W.M. being 1800 feet South and 2830 feet East from W 1/4 corner Section 11.


