## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON DEPARTMENT OF ADMINISTRATIVE SERVICES SALEM, OREGON 97310

confirms the right to use the waters of MILL CREEK, a tributary of the WILLAMETTE RIVER, for SUPPLEMENTAL IRRIGATION OF 59.8 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for MARION County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 14, at Page 357. The date of priority is 1891.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.68 CUBIC FOOT PER SECOND (304 GALLONS PER MINUTE) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE $\frac{1}{4}$  SE $\frac{1}{4}$  , as projected within J HERREN DLC 60, SECTION 18, T. 8S., R.2W., W.M.; 1140 FEET NORTH AND 4850 FEET EAST FROM SW CORNER, SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

- 17.0 ACRES LOT 4 ( $NW_4^1$  SE $\frac{1}{4}$ )
- 3.2 ACRES NW4 SE4 as projected within J. HERREN DLC 60
- 2.0 ACRES LOT 5 (SW $^{1}_{4}$  SE $^{1}_{4}$ )
- 13.2 ACRES  $SW_4^1$   $SE_4^1$  as projected within J. HERREN DLC 60
- 24.4 ACRES SE<sup>1</sup><sub>4</sub> SE<sup>1</sup><sub>4</sub> as projected within J. HERREN DLC 60 SECTION 18

TOWNSHIP 8 SOUTH, RANGE 2 WEST, W.M.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
