## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SCOTT BUSBY 1404 STONE CREEK COURT (P.O. BOX 430) MARTINEZ, CALIFORNIA 94553

confirms the right to use the waters of UMPQUA RIVER, a tributary of PACIFIC OCEAN, for IRRIGATING 119.8 ACRES.

This right was perfected under Permit 50928. The date of priority is JULY 17, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.95 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 23, T 25 S, R 7 W, W.M.; 3000 FEET NORTH AND 1310 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

Diversion screening or fish passage facilities shall be maintained and operated to Oregon Department of Fish & Wildlife specifications.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
