CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the PATAWA CREEK BASIN for DOMESTIC USE FOR 58 FAMILIES.

This right was perfected under Permit G-5283. The date of priority is OCTOBER 8, 1970. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.20 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

ORIGINAL: SW 1/4 SE 1/4, SECTION 28, T 2 N, R 33 E, W.M.; NORTH 24 DEGREES 52 MINUTES WEST 184.86 FEET FROM THE SE CORNER OF THE SW 1/4 SE 1/4 OF SECTION 28.

NEW: SW 1/4 SE 1/4, SECTION 28, T 2 N, R 33 E, W.M.; NORTH 24 DEGREES 46 MINUTES 30 SECONDS WEST 143.17 FEET FROM THE SE CORNER OF THE SW 1/4 SE 1/4 OF SECTION 28.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 SECTION 28 TOWNSHIP 2 NORTH, RANGE 33 EAST, W.M.

MORE EXPLICITLY DESCRIBED AS LOTS 1-11, BLOCK 1; LOTS 3-24, BLOCK 2; LOTS 1-11, BLOCK 3; LOTS 1-15, BLOCK 4 OF SHENANDOAH ESTATES.

The quantity of water diverted at the new point of appropriation, together with that diverted at the original well located North 24 degrees 52 minutes West, 184.86 feet from the SE corner of the SW 1/4 SE 1/4, Section 28, being within the SW 1/4 SE 1/4, Section 28, t 2 N, R 33 E, W.M., shall not exceed 0.20 CFS.

Water shall be aquired at the new point of appropriation from the same aquifer as the original point of appropriation.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The user shall maintain the flow meters and record the quantity of water used from both wells.
