CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORPAC FOODS INC.

confirms the right to use the waters of NORTH SANTIAM RIVER AND DETROIT RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, a tributary of SANTIAM RIVER, for IRRIGATION OF 148.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 49.4 ACRES.

This right was perfected under Permit 50720. The dates of priority are NOVEMBER 8, 1988 - FOR USE FROM THE RIVER; AND JUNE 28, 1989 - FOR USE FROM THE RESERVOIR. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.92 CUBIC FEET PER SECOND, FROM THE NORTH SANTIAM RIVER FOR IRRIGATION OF TRACT 1 (148.2 ACRES) AND USE OF NOT MORE THAN 494.0 ACRE-FEET ANNUALLY FROM DETROIT RESERVOIR FOR SUPPLEMENTAL IRRIGATION OF TRACT 1 AND TRACT 2 (49.4 ACRES), or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SECTION 20, T 9 S, R 1 W, W.M.; 1320 FEET NORTH & 2160 FEET WEST FROM THE SE CORNER OF SECTION 20.

SE 1/4 SW 1/4, SECTION 20, T 9 S, R 1 W, W.M.; 1230 FEET NORTH & 310 FEET WEST FROM THE S 1/4 CORNER OF SECTION 20.

RESERVOIR - SW 1/4 NW 1/4, SECTION 7, T 10 S, R 5 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
