 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LUCIUS ROBINSON
 KERBY, OREGON

confirms the right to use the waters of ILLINOIS RIVER AND EAST FORK ILLINOIS RIVER, tributaries of the ROGUE RIVER, for the purpose of IRRIGATING 62.8 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 13, at page 70. The date of priority is MAY, 1887.

The amount of water to which this right is entitled for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed ONE CUBIC FOOT PER SECOND FOR EACH 50 ACRES OF LAND IRRIGATED DURING THE IRRIGATION SEASON FROM APRIL 1 TO NOVEMBER 1 OF EACH YEAR.

The points of diversion are located as follows:

SE 1/4 NW 1/4, SECTION 27, T 39 S, R 8 W, W.M. - KERBYVILLE MILLING AND IRRIGATION COMPANY DITCH FOR TRACT 1 AND LOT 6 (SE 1/4 SW 1/4), SECTION 33, T 38 S, R 8 W, W.M. - 670 FEET NORTH AND 1560 FEET EAST FROM THE SW CORNER OF SECTION 33 FOR TRACT 2.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
