CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELVINE E. CARTER ROUTE 1, BOX 210 BAKER CITY, OREGON 97814

confirms the right to use the waters of CARTER SUMP 1 in the PINE CREEK (BAKER VALLEY) BASIN for TRRIGATION OF 15.9 ACRES AND SUPPLEMENTAL TRRIGATION OF 42.0 ACRES.

This right was perfected under Permit G-6901. The date of priority is MAY 27, 1976. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.72 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

LOT 2 (SW½ NW½) AND SE½ NW½, SECTION 30, T 8 S, R 39 E, W.M.; SUMP 1 - 380 FEET NORTH AND 270 FEET EAST FROM THE W½ CORNER OF SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
