CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH V. KRUSE AND KATHLEEN G. KRUSE GENERAL DELIVERY FORT ROCK, OREGON 97735

confirms the right to use the waters of 4 WELLS in the BUCK CREEK BASIN for IRRIGATION OF 783.2 ACRES.

This right was perfected under Permit G-7361. The date of priority is APRIL 29, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 9.8 CUBIC FEET PER SECOND, BEING 1.14 CFS FROM WELL 1; 3.61 CFS FROM WELL 2; 1.99 CFS FROM WELL 3; AND 3.06 CFS FROM WELL 4 or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

WELL #1 - NW 1/4 NE 1/4, SECTION 12, T 26 S, R 14 E, W.M.; 17.1 CHAINS SOUTH AND 22.8 CHAINS WEST FROM THE NE CORNER SECTION 12.

WELL #2 - NW 1/4 NE 1/4, SECTION 13, T 26 S, R 14 E, W.M.; 650 FEET SOUTH AND 1910 FEET WEST FROM THE NE CORNER OF SECTION 13.

WELL #3 - NE 1/4 SE 1/4, SECTION 13, T 26 S, R 14 E, W.M.; 1330 FEET NORTH AND 1310 FEET WEST FROM THE SE CORNER OF SECTION 13.

WELL #4 - NE 1/4 SE 1/4, SECTION 1, T 26 S, R 14 E, W.M.; 2300 FEET NORTH AND 1310 FEET WEST FROM THE SE CORNER OF SECTION 1

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The following provisions shall be effective when in the judgement of the Watermaster it becomes necessary to install measuring devices:

the pump system shall include an access port for measuring the water level;

the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
