CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EDMUND DUYCK 2020 SW 325TH AVENUE HILLSBORO, OR 97123

confirms the right to use the waters of DAIRY CREEK, a tributary of TUALATIN RIVER, for IRRIGATION OF 44.0 ACRES.

This right was perfected under Permit 14050. The date of priority is OCTOBER 9, 1939. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.55 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, WITHIN DLC 50, SECTION 1, T 1 S, R 3 W, W.M.; 1050 FEET NORTH AND 480 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
