CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the LITTLE DESCHUTES RIVER, a tributary of the DESCHUTES RIVER, for irrigating 63.1 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for DESCHUTES County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at Page 451. The date of priority is 1907.

The use is limited to 3.0 acre-feet per acre measured at the point of diversion from the source and shall be further limited to not to exceed 1.8 acre-feet per acre delivered on the land for each acre irrigated during the irrigation season from April 1 to July 1 of each year.

The point of diversion is located as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 34, T 23 S, R 9 E, W.M.; 550 FEET NORTH AND 1150 FEET EAST FROM THE SW CORNER OF SECTION 34.


