## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ODELL ADAMS P.O. BOX 143 SPRAY, OREGON 97874 SPRAY SCHOOL DISTRICT P.O. BOX 230 SPRAY, OREGON 97874

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 3.1 ACRES (ADAMS) AND IRRIGATION OF 2.7 ACRES (SPRAY SCHOOL DISTRICT).

This right was perfected under Permit 50662. The date of priority is OCTOBER 21, 1987. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.14 CUBIC FOOT PER SECOND, BEING 0.075 CFS FOR ADAMS AND 0.065 CFS FOR SPRAY SCHOOL DISTRICT or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

ADAMS: SW 1/4 NE 1/4, SECTION 36, T 8 S, R 24 E, W.M.; 1320 FEET SOUTH AND 1920 FEET WEST FROM THE NE CORNER OF SECTION 36.

SPRAY SCHOOL DISTRICT: SW 1/4 NE 1/4, SECTION 36, T 8 S, R 24 E, W.M.; 1750 FEET SOUTH AND 1650 FEET WEST OF THE NE CORNER OF SECTION 36.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acrefeet per acre for each acre irrigated during the irrigation season of each year, BEING FURTHER LIMITED TO 0.2 ACRE-FOOT PER ACRE IRRIGATED DURING MAY; 0.6 ACRE-FOOT PER ACRE IRRIGATED DURING JULY; 0.7 ACRE-FOOT PER ACRE IRRIGATED DURING JULY; 0.7 ACRE-FOOT PER ACRE IRRIGATED DURING AUGUST AND 0.1 ACRE-FOOT PER ACRE IRRIGATED DURING SEPTEMBER.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When in the judgement of the Watermaster it becomes necessary to measure and keep a record of the amount of water being diverted, the right allowed herein shall be subject to the installation and maintenance of in-line flow meters, weirs, or other suitable devices for measuring the water.

The use of water under this right is contingent upon continuing compliance with the conditions of any required discharge permit for water quality control held by the water user.
