CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

A-D DAIRY ANTHONY AGUIAR 3153 GALICE ROAD MERLIN, OR 97532

confirms the right to use the waters of LOST CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-8142, a tributary of ROGUE RIVER, for PRIMARY IRRIGATION OF 2.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 47.0 ACRES.

This right was perfected under Permit 50762. The date of priority is APRIL 12, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 150.0 ACRE-FEET OF STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 14, T 35 S, R 7 W, W.M.; 938 FEET NORTH AND 3853 FEET WEST FROM THE W 1/4 CORNER OF SECTION 13.

The amount of water used for irrigation shall be further limited to a diversion of not to exceed 4.5 acrefeet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
