CERTIFICATE OF WATER RIGHT

EAGLE POINT IRRIGATION DISTRICT

EAGLE POINT, OREGON 97524

confirms the right to use the waters of BIG BUTTE CREEK, a tributary of ROGUE RIVER, for the purpose of IRRIGATION OF 714.7 acres.

This right was perfected under Permit 6396. The date of priority is April 21, 1915. This right is limited to an amount of water actually beneficially used for said purposes, and shall not exceed 8.72 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 10, Lot 4, (NW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 3, T.35 S., R.2 E., W.M.; diversion point 1: 1130 feet South and 700 feet West from the NE Corner, Section 10; diversion point 2: 1,030 feet South and 290 feet East from NW Corner, Section 3.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
