CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEPHEN C. TROUT 16294 HIGHWAY 38 ELKTON, OR 97436

confirms the right to use the waters of UMPQUA RIVER, a tributary of PACIFIC OCEAN, for IRRIGATING 55.8 ACRES.

This right was perfected under Permit 51070. The date of priority is JULY 23, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.69 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

#1 - SW 1/4 SE 1/4, SECTION 20, T 22 S, R 8 W, W.M.; 400 FEET NORTH AND 1980 FEET WEST FROM THE SE CORNER OF SECTION 20.

#2 - SE 1/4 SE 1/4, SECTION 20, T 22 S, R 8 W, W.M.; 530 FEET NORTH AND 570 FEET WEST FROM THE SE CORNER OF SECTION 20.

#3 - SE 1/4 SE 1/4, SECTION 20, T 22 S, R 8 W, W.M.; 850 FEET NORTH AND 200 FEET WEST FROM THE SE CORNER OF SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
