## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES L. GIROD P.O. BOX 228 MILL CITY, OREGON 97360

confirms the right to use the waters of THE NORTH SANTIAM RIVER AND DETROIT RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, a tributary of WILLAMETTE RIVER, for IRRIGATION OF 2.7 ACRES.

This right was perfected under Permit 51186. The date of priority is NOVEMBER 1, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.033 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

This right is limited to 0.033 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NW 1/4, SECTION 31, T 9 S, R 3 E, W.M.; 350 FEET SOUTH AND 180 FEET EAST FROM THE NW CORNER OF SECTION 31.

DETROIT RESERVOIR: SW 1/4 NW 1/4, SECTION 7, T 10 S, R 5 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year FROM DIRECT FLOW AND STORAGE.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NW 1/4 2.7 ACRES SECTION 31 TOWNSHIP 9 SOUTH, RANGE 3 EAST, W.M.

Diversion screening or fish passage facilities shall be maintained and operated to Oregon Department of Fish & Wildlife specifications.

The water user shall comply with the terms and conditions of Contract #1-07-10-WO827 dated January 17, 1991, between the Bureau Of Reclamation and James L. Girod. A copy of the contract is in Application File 70846 at the Water Resources Department.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.
