confirms the right to use the waters of FOUR WELLS in the CROOKED RIVER BASIN for PRIMARY IRRIGATION OF 533.8 ACRES AND SUPPLEMENTAL OF 112.7 ACRES.

This right was perfected under Permit G-8720. The dates of priority are DECEMBER 11, 1978 - FOR 409.8 ACRES OF PRIMARY AND 16.3 ACRES OF SUPPLEMENTAL; AND DECEMBER 28, 1978 - FOR 124.0 ACRES OF PRIMARY AND 96.4 ACRES OF SUPPLEMENTAL. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 8.08 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL #1 - SW 1/4 SE 1/4, SECTION 11, 980 FEET NORTH AND 1950 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 11. WELL #2 - NE 1/4 SW 1/4, SECTION 11, 2550 FEET NORTH AND 2550 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 11. WELL #3 - SW 1/4 NE 1/4, SECTION 11, 2060 FEET SOUTH AND 2600 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 11. WELL #4 - SW 1/4 SE 1/4, SECTION 11, 1090 FEET NORTH AND 1480 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 11, ALL WITHIN T 15 S, R 14 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The user shall maintain a weir, meter, or suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be subsequently reduced.

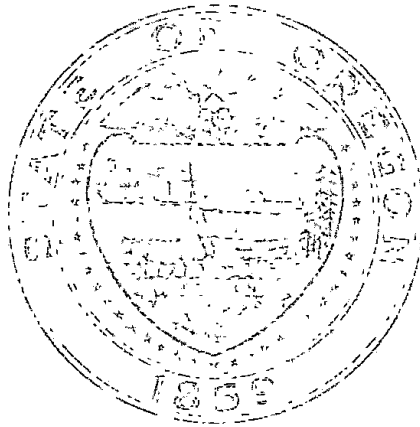
