CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LINCOLN HORIZONS, INC.
11875 ORRS CORNER ROAD
DALLAS, OR 97338

confirms the right to use the waters of RICKREALL CREEK, a tributary of WILLAMETTE RIVER, for IRRIGATION OF 3.91 ACRES.

This right was perfected under Permit 28133. The date of priority is AUGUST 10, 1951 - FOR TRACT 1, AND JUNE 20, 1962 - FOR TRACT 2. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.049 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 63, SECTION 35, T 7 S, R 5 W, W.M.; 390 FEET SOUTH AND 420 FEET EAST FROM THE NE CORNER OF DLC 66.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 7 SOUTH, RANGE 5 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 18, 1988, and together with Certificates 57560 AND 60835, supersedes Certificates 21314 AND 34287, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
