CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J.R. SIMPLOT COMPANY P.O. BOX 218 PENDLETON, OREGON 97801

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 15.0 ACRES.

The right has been perfected under Permit 32631. The date of priority is MAY 25, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.20 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

(ORIGINAL) #1 - NW 1/4 NW 1/4, SECTION 34, T 4 N, R 28 E, W.M.; 750 FEET SOUTH AND 50 FEET EAST FROM THE NW CORNER OF SECTION 34.

(ADDITIONAL) #2 - SE 1/4 SE 1/4, SECTION 27, T 4 N, R 28 E, W.M.; 140 FEET NORTH AND 710 FEET WEST FROM THE SE CORNER OF SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NW 1/4 13.8 ACRES NW 1/4 NW 1/4 1.2 ACRES SECTION 34 TOWNSHIP 4 NORTH, RANGE 28 EAST, W.M.

The quantity of water diverted at the new point of diversion, together with that diverted at the old diversion, shall not exceed the quantity of water available at the original point of diversion.

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 25, 1985 and supersedes certificate 51354, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
