CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THE DEPARTMENT OF VETERANS' AFFAIRS 700 SUMMER STREET NE SALEM, OREGON 97310-1201 DVA C-20974

confirms the right to use the waters of A WELL in the UMATILLA BASIN for SUPPLEMENTAL IRRIGATION OF 10.0 ACRES.

This right was perfected under Permit G-1854. The date of priority is MAY 8, 1961. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.13 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

SW 1/4 SE 1/4, SECTION 6, T 3 N, R 29 E, W.M.; 75 FEET NORTH AND 1285 FEET EAST FROM THE S 1/4 CORNER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 10.0 ACRES SECTION 6 TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.

Water shall be acquired from the same aquifer as the original point of appropriation.

When in the judgement of the department it becomes necessary to install measuring devices, the pump systems shall include an in-line flow meter or other suitable device for measuring the water to which the user is entitled. The type and plans of the measuring device must be approved by the Department before the beginning of construction work and the measuring device shall be installed under the general supervision of the Department.

The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water available at the original point of appropriation.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered December 12, 1989, and supersedes Certificate 32593, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
