CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of NAROMA CREEK, a tributary of the LITTLE NORTH FORK SANTIAM RIVER, for DOMESTIC USE.

This right was perfected under Permit 12231. The date of priority is JUNE 23, 1936. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.01 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW4 NE4, SECTION 15, T 9 S, R 2 E, W.M.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this might is appurtenant is as follows:

LAND ON WHICH WATER IS TO BE USED IS A PART OF THE PROPERTY MORE EXPLICITLY DESCRIBED BY APPROPRIATOR AS FOLLOWS:

BEGINNING AT A POINT ON THE SOUTH LINE OF THE SW% OF THE SE% OF SECTION 10 IN TOWNSHIP 9 SOUTH, RANGE 2 EAST OF THE WILLAMET'TE MERIDIAN, MARION COUNTY, OREGON, WHICH POINT IS 1050 FEET EAST OF THE QUARTER CORNER ON THE SOUTH LINE OF SAID SECTION, THENCE EAST 70 FEET MORE OR LESS TO THE CENTER LINE OF NAROMA CREEK; THENCE NORTHERLY ALONG THE CENTER LINE OF SAID CREEK TO A POINT WHICH IS 80 FEET MORE OR LESS SOUTHERLY ALONG SAID CENTER LINE OF SAID CREEK FROM THE CENTER LINE OF THE LITTLE NORTH FORK OF THE SANTIAM RIVER, AND WHICH POINT IS ON A LINE RUNNING DUE NORTH OF THE PLACE OF BEGINNING; THENCE SOUTH 175 FEET MORE OR LESS TO THE PLACE OF BEGINNING.

BEGINNING AT THE SE CORNER OF THE SW% OF THE SE% OF SECTION 10 IN TOWNSHIP 9 SOUTH, RANGE 2 EAST OF THE WILLAMETTE MERIDIAN, MARION COUNTY, OREGON; THENCE WEST ALONG THE SOUTH LINE OF SECTION 10, 200 FEET, MORE OR LESS TO A SMALL (NAROMA) CREEK; THENCE NORTHERLY FOLLOWING THE MIDDLE OF SAID CREEK TO THE MIDDLE OF THE LITTLE NORTH FORK OF THE SANTIAM RIVER; THENCE EASTERLY FOLLOWING THE MIDDLE OF SAID RIVER, 200 FEET, MORE OR LESS, TO THE EAST LINE OF SAID % SECTION, THENCE SOUTH TO THE PLACE OF BEGINNING.

This certificate describes that portion of the water right confirmed by Certificate 14610, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered ________, approving Transfer Application 7053.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
