## CERTIFICATE OF WATER RIGHT

This is to Certify, That I. M. DAVIS

of Drewsey, State of Oregon has a right to the use of

the waters of Little Muddy Creek for Tract #1; Middle Fork Malheur for Tract #2;  
 Malheur River for Tract #3;  
 for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
 Malheur County, and the said decree entered of record at Salem, in the Order  
 Record of the STATE ENGINEER, in Volume 8, at page 223; that the priority  
 of the right thereby confirmed dates from 1383 for Tract #1; 1694 for Tracts #2 and  
 #3;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
 amount actually beneficially used for said purposes, and shall not exceed 1 $\frac{1}{2}$  acre feet per acre  
 in any 30-day period prior to June 1st, 1 acre foot per acre in any 30-day period  
 after June 1st, of each year, or 3 acre feet per acre during any season, diverted  
 at a rate not to exceed one-twentieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant  
 (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1: 3 acres in the SW $\frac{1}{2}$ SE $\frac{1}{2}$ , 37 acres in the SE $\frac{1}{2}$ SE $\frac{1}{2}$ , Section 15; 40 acres  
 in the SW $\frac{1}{2}$ SW $\frac{1}{2}$ , 15 acres in the SE $\frac{1}{2}$ SW $\frac{1}{2}$ , Section 14; 20 acres in the  
 NE $\frac{1}{2}$ NE $\frac{1}{2}$ , 13 acres in the NW $\frac{1}{2}$ NE $\frac{1}{2}$ , Section 22; 10 acres in the NW $\frac{1}{2}$ NW $\frac{1}{2}$ ,  
 Section 23, T. 20 S. R. 35 E. W. M., being a total of 138 acres

Tract #2: 16 acres in the NE $\frac{1}{2}$ SW $\frac{1}{2}$ , 10 acres in the NW $\frac{1}{2}$ SW $\frac{1}{2}$ , 6 acres in the SW $\frac{1}{2}$ SE $\frac{1}{2}$ ,  
 32 acres in the SE $\frac{1}{2}$ SE $\frac{1}{2}$ , Section 23, T. 20 S. R. 35 E. W. M., being a  
 total of 64 acres.

Tract #3: 20 acres in the NE $\frac{1}{2}$ SE $\frac{1}{2}$ , 32 acres in the NW $\frac{1}{2}$ SE $\frac{1}{2}$ , 25 acres in the SW $\frac{1}{2}$ SE $\frac{1}{2}$ ,  
 50 acres in the SE $\frac{1}{2}$ SE $\frac{1}{2}$ , Section 21, 35 acres in the SW $\frac{1}{2}$ SW $\frac{1}{2}$ , Section 22,  
 T. 20 S. R. 35 E. W. M., being a total of 142 acres.

And said right shall be subject to all other conditions and limitations  
 contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place  
 of use herein described.
